

## STATEMENT OF CONSENT

- 1) I consent and accept that my minor child participates with his voice and image in photography and videography for the communication of the Panhellenic STEM & Educational Robotics Competition WRO Hellas 2023 on the subject of robotics, with the aim of projecting the visual and/or audio and/ and audio-visual material to be produced (hereinafter "Project") in print and electronic media and in particular in radio, television, cinema, daily and periodical press, on the internet (websites of an informative nature, on the COSMOTE website (including the one maintained on social media) and the general advertising and commercial exploitation of the above material and any event and/or event related to the Action, without the obligation to inform me or the right to receive a fee or any other compensation.
- 2) I agree, acknowledge and accept that the above does not infringe the personality and other rights of my child arising from articles 57 et seq. of the Civil Code, and in any case I waive any related claim or objection.
- 3) I hereby assign and transfer to COSMOTE all the intellectual and related rights of my child related to my child's voice and image participation in the Project, for the above-mentioned uses, worldwide and in perpetuity, COSMOTE being entitled to exercise absolutely all powers arising from it including their transfer. By way of example and not limitation, I assign and transfer without financial consideration the following rights of my child on the Project: (a) the right to first record the image, voice, etc. of my child by mechanical or other means on material carriers of sound and/or image of any form, (b) the right to direct or indirect, temporary or permanent reproduction of copies of the material carriers in any form of material audio and/or image carriers and exploitation of these carriers in any way, (c) the right to publicly present, perform, download, transmit and rebroadcast the Project to the public in the above media and d) the right to unrestricted use of the Project for internal use and archival reasons as well as for its presentation at COSMOTE SA events and awards , the latter exempted from any liability for the dissemination of the Project via the Internet.
- 4) I have no present or future demand or claim of any nature whatsoever for the delivery of a copy of the Work.
- 5) I acknowledge and declare responsibly and unreservedly that there is no right to attack my statements under par. 1, 2, 3 and 4, which constitute my free, express and unreserved statements. In addition, I acknowledge that no demand or claim, of any nature, arises either from the personality of my child or from the exploitation of the Project in the present and in the future against COSMOTE because of my statements under par. 1, 2, 3, and 4 .
